



Job Description: Psychiatric Medication Management Physician or Nurse Practitioner

We are seeking a dedicated and compassionate medical doctor or nurse practitioner to provide medication management services on a part-time basis. - Maintain accurate and timely documentation of all client interactions, including treatment plans, progress notes, and medication records
- Keep up-to-date with the latest research and developments in psychiatric medication management and related fields
