Peninsula Behavioral Health (PBH; www.penbh.com) is a growing outpatient group clinical psychology private practice dedicated to providing high-quality, evidence-informed care to the San Francisco Bay Area and beyond. Our mission is to deliver psychotherapy in a highly client-centered, professional, and collaborative environment. In addition to general mental health practice, PBH houses several specialty sub-clinics, including clinics specializing in eating disorders, trauma, women's wellness, child/family, and relationships.

PBH strongly values cultural humility and diversity. We seek to be sensitive to the many roles that diversity plays in our clients' lives, in the delivery of our services, and within our organization. We are committed to providing equal opportunity in all practices. We are currently seeking licensed clinical psychologists or masters-level clinicians to join our team. Candidates with expertise in working with various forms of diversity and/or representing backgrounds typically underrepresented in the mental health field are encouraged to apply.

We are centered in Palo Alto and currently primarily provide services virtually. Providers practice from their preferred locations, which include the San Francisco Bay Area and beyond. We currently have a satellite clinic located in San Diego and we plan to continue to expand geographically.

Candidates must be licensed or license-eligible clinical psychologists or masters-level clinicians in the state of California and demonstrate excellence in evidence-informed practice. Positions are highly flexible with regard to work schedule and caseload size, ranging from two evenings per week to full-time work. Providers have clinical autonomy to independently select cases, and intervene according to preferred orientation. Providers may also have opportunities to



supervise or teach in PBH's training program, assume administrative roles, and/or develop programming. Interested candidates should be willing to make a 12-month commitment.

Adult Therapists

PBH is seeking clinicians with expertise in providing evidence-informed individual, couples and group interventions to adults. PBH treats a broad range of psychological conditions, and positions are open to both generalists and specialists. The opportunity to practice in PBH's specialty clinics may be of particular interest to candidates with these areas of expertise. Individuals with expertise in couples/family therapy and eating disorder treatment are especially encouraged to apply.

Child Therapists

PBH is seeking child therapists to provide evidence-informed individual, group, and/or family interventions to children, adolescents, and their caregivers. Areas of clinical expertise may include (but is not limited to) mood and anxiety disorders, ADHD and behavioral disorders, eating disorders, and/or learning and developmental disorders. Opportunities to develop a



psychological assessment program and to assume other administrative responsibilities may be available to interested candidates.

Virtual Care

We will continue to offer services virtually in perpetuity. Candidates licensed in California who wish to provide virtual therapy from a remote location are welcome to apply. PBH is also willing to support providers with licenses in other states to develop a local practice, in addition to treating clients in California.
